Question 1

Thabo, a twenty three year old male of Nazareth and Nthabiseng, a twenty one year old female of Roma, Ha Mafefoane have been engaged for five months. Nthabiseng is employed as a nurse at St. Joseph's Hospital in Roma while Thabo is a senior manager at Standard Lesotho Bank in Maseru. Thabo purchased a diamond engagement ring for Nthabiseng worth M10, 000.00. He also paid M8, 000.00 tuition fee for Nthabiseng who had enrolled for a Diploma in Business Management at the Institute of Extra Murial Studies in Maseru.

Thabo unexpectedly paid Nthabiseng a visit one Wednesday evening after knocking off from work and found her embracing and kissing Paul passionately. Thabo and Paul were very close friends.

Thabo wants to terminate the engagement and has come to you for legal advice. Making reference to legal authorities, advise him accordingly.

Question 4

Libuseng, a twenty six year old female of Ha Thamae has been married to Thabiso, a thirty year old male of Ha Tsosane for a period of four years. Libuseng is a cleaner earning M800. 00, St. Joseph's Hospital in Roma. Thabiso is an immigration officer in the Ministry of Home Affairs earning M8000, 00 per month. The parties have two children, namely Sello, an eleven year old boy and Mats'eliso, an eight year old girl. Both children are enrolled at the Roma Primary School. The school fees for both children amount to M3000, 00 per year.

Owing to marital difficulties which often led to physical fights between the parties, an order of judicial separation was issued by the court at the instance of Libuseng. Custody of the children was awarded to Libuseng.

In disbelief, he approaches you as his lawyer to assist him to obtain a decree of judicial separation while pondering whether or not to divorce his wife.

Question 6

Mr. and Mrs. Bean are married in community of property. Mrs. Bean found living with her husband intolerable as he had become a violent habitual drunkard. She subsequently left the matrimonial home and is living with her brother in rented property. Mr. Bean tried on several occasions to persuade her to return home but has never been successful. On most occasions he was not violent but always very drunk. Last month he approached her again and to her surprise he was not

intoxicated at all. Unfortunately he was not able to convince her to go home and out of frustration, he assaulted her and she was subsequently hospitalized. The hospital has sent a bill to him and he is refusing to pay saying that her brother is liable to pay the bill because she is under his care.

She has been advised that she is going to need a special bed at home. She therefore asked her husband to allow her to purchase the bed on hire-purchase terms, but he has not been coorporative at all and in most instances too drunk to even appreciate what she is saying. She is frustrated and does not know what to do because her brother, who is experiencing financial difficulties, does not have means to purchase the bed. Her brother has even asked her to help him pay rent following a notice of eviction that he received from his landlord.

Mrs. Bean has come to you for legal advice on the issues arising from the above facts. Making reference to legal authorities, advise her on issues pertaining to maintenance.
