Ralinku is a livestock farmer of Lihlabeng. In the last three (3) years Ralinku has been a victim of various attacks of stock theft. In all these instances, the thieves were armed with automatic rifles.

Ralinku owns a small 7.65 calibre pistole, with which he has not been able to repel the thieves. In January 2023, Ralinku applied for an automatic rifle license. For one year he has not been furnished with any response from the Commissioner of Police, who is vested with the power to grant fire arm licences.

After several reminders, Ralinku has finally received a response from the Assistant Commissioner of Police captioned in the following terms "I regret to inform you that your application has been unsuccessful."

Ralinku is unhappy with the response and has come to you for legal advice.

Advise him accordingly.

QUESTION SIX

The University of Selomong Act No.15 of 1997 vests the disciplinary powers of the University in the Senate. This power can either be exercised by the Senate itself or any other person or body acting under the authority of Senate.

In August 2023, the office of the Director of Student Affairs received a report that Senokoane, a third year student had fatally stabbed a fellow student. The incident was reported to the Vice Chancellor as the Chief Executive of the University.

The Vice Chancellor has since written a letter to Senokoane informing him that he has been expelled from the University with immediate effect.

Senokoane is unhappy with the decision of the Vice Chancellor and has come to you for legal advice.

Advise him accordingly.
