QUESTION 1

On 24 May 2022, Lesotho Times Newspaper published an article in which one of the lawyers in Lesotho lodged a constitutional case claiming that the provisions on conferment of title of King's Counsel under the Legal Practitioners Act, 1983 are discriminatory and unconstitutional as they deny younger, yet brilliant lawyers to be conferred with such a titled.

a) Discuss the requirements which one has to meet in order to receive the title of King's Counsel. In your response, address the merits and demerits of the claim in the above case.

b) In the case cited above, one of the arguments is that the conferment should be done by the King on the recommendation of the Law Society. Discuss the current legal position, its challenges if any, whether you agree that it should be changed.

QUESTION 3

Thato is was admitted as an Advocate of the Courts of Lesotho in August 2020. After three years of practice, she realizes that there is a gap as many clients need services, which can only be provided by Notary Publics yet there are very few of them in Lesotho. Taking into account the provisions of the Legal Practitioners Act, what steps should Thato follow in order for her to be admitted as a Notary Public?

(b) On 14 December 2002, Mr. Thabo had a car accident. He sought services of TinTan Attorneys to lodge a motor accident claim with Lesotho National Insurance Group (LNIG). The claim was honoured and he was paid a sum of Five Hundred Thousand Maloti (M500 000.00) which was paid into the TinTan Attorneys Trust Account. However, upon enquiry, Mr Thabo was told that LNIG paid Two Hundred Thousand Maloti (M200 000.00) from which legal fees and collection commission shall be deducted. He happily received the amount of One Hundred and Fifty Maloti (M150 000.00). Two months later, he received from the post office, a statement

reflecting a payment of Five Hundred Thousand Maloti (M500 000.00) for his claim.

He has approached TinTan Attorneys and he was told that his file is closed and therefore he cannot be attended. Mr Thabo has approached you for advice as to where he can lodge the complaint of dishonesty against TinTan Attorneys.

With reference to relevant provisions of the Legal Practitioners Act and case law, advise him.
