#### **QUESTION 1**

Conflicts at workplaces seem to be increasing at an alarming rate in Lesotho and the economy is taking a knock due to unprotected strikes and unlawful protests.

#### **QUESTION 2**

Tumelo and Kitso have a packet of 30 multi-coloured sweets. They want to share the sweets in manner that will leave both of them happy. Tumelo is the elder one and he has the sweets in his custody.

- (a) Scenario 1: Tumelo wants to take all the red and purple sweets because they are sweeter and richer in taste. He says because he is the eldest, he has to choose first. Kitso also wants the red and purple because both are his favourite colours and he knows that they are strawberry and grape flavours which he loves very much. Their mother tries to help them decide but after seeing that they cannot agree she decides to keep the whole packet of sweets.
- (b) Scenario 2: Kitso, realising that Tumelo is indeed the eldest, allows Tumelo to take all the red and purple sweets.
- (c) Scenario 3: Tumelo decides to be a big brother and allows Kitso to take all the red and purple sweets.
- (d) Scenario 4: Tumelo decided to find out from Kitso, why he wants the red and purple sweets. Kitso explains that they are his favourite colours

and he likes the strawberry and grape flavours. Kitso then asks Tumelo why he wants the red and purple sweets and he says they are sweeter and have a rich taste. Tumelo admits that he does not have a problem taking just a few of the red and purple sweets because as much as they are sweet, they become too much if not mixed with a subtler taste like the orange ones. Kitso says he also does not mind taking a few of the red and purple because he wants to try the orange and green as he has never tasted them before. They share the mixture of sweets equally and both are happy.

These scenarios explain four very distinct outcomes in negotiations. Explain the features of these outcomes fully and their costs and benefits.
