QUESTION 6

Matsoso and Borotho stole one hundred and twenty packets of 12.5 kg of hullets sugar from Bingo wholesale in Maseru. They divided the loot between them and Matsoso took 50 and Borotho 70 respectively. Matsoso sold his share to his uncle Robert who runs a restaurant at Roma; while Borotho sold 50 of his packets to James a farmer in Hlotse and gave the other 20 packets to his cousins Simon and Thabo who have a shop in Maputsoe.

Matsoso and Borotho were arrested and upon the arrest M5000 was found on the person of Borotho but nothing was found on Matsoso except a bank deposit slip of M10000.

Simon and Thabo were arrested and charged with receiving stolen property knowing it to have been stolen.

The evidence against James and Robert was circumstantial at best and the prosecution dropped the charges.

(a) Discuss the statutory provisions that the court needs to rely on when deciding search and seizure of perishables.
